- The candidate who does not want to retain the allotted seat, but is interested in second round and is willing to hold the current seat will have to pay online processing fee of Rs. 1000/- per admission round as mentioned in the Information Bulletin and the receipt of the same should be uploaded online on the website.
- For a private quota candidate to retain the seat Rs.2,00,000/- (Rupees Two lakhs only) is the annual fees to be paid. The receipt of the paid annual fee is to be uploaded online on the website. The annual fee paid by the private candidate will be considered as SEAT RETENTION FEE.
- For the in-service candidates who wants to retain the in-service quota seat, the seat retention fee will be Rs.5000/-. The in-service candidate does not have any annual fees hence the seat retention fees have to be paid and the receipt of the same should be uploaded online on the website.
